

I thought that this book was very informative. It introduced us, me and my classmates, to many aspects of law, not just the duties of a paralegal. The textbook covers guidelines for practicing legal assistants, branches of the state and federal court systems, how to read and write citations, which publications and websites paralegals need to use when employed in the field, a glossary, helpful hints provided by legal scholars and attorneys, the full US Constitution (including the amendments), diagrams, sample documents, and much more. "Paralegal Today" even included a 38 page SKILL PREP index, offering students suggestions about studying. I recommend this book for anyone whether you are pursuing a degree or certificate.
